

## **NOTICE TO BIDDERS**

Notice is hereby given that the City of Lake Station Stormwater Utility (Utility) will receive sealed bids for the above described "Project/Work" at the Lake Station Utility Building, 4325 Liverpool Road, Lake Station, Indiana, until 4:30 p.m. prevailing local time, on February 9, 2026 or, thereafter, to the Board of Directors during its meeting scheduled to begin at 4:30 pm on the same date and at the same place. Such timely received bids will be publicly opened at that time. No late Bids will be accepted and will be returned unopened.

A Bid Bond or certified check in an amount not less than five percent (5%) of the bid amount must be submitted with each Bid. A one hundred percent (100%) Performance and Payment Bond will also be required of the successful Bidder.

The Work consists of, but is not necessarily limited to the following:

**Installation of 1,248 linear feet of 36-inch thru 12-inch storm sewers, 824 linear feet of 18-inch and 8-inch sanitary sewer, 9 manholes, 5 inlets, outfall at Deep River, 322 linear feet of new curbs along intersection of Central Avenue and Union Street, pavement repair, clearing and associated site restoration.**

Contract Documents for the Project/Work have been assembled into one or more bound Project Manuals which, together with Drawings, may be examined at the Utility Building, 4325 Liverpool Road, Lake Station, Indiana 46405.

**A pre-bid conference will be held at 10:00 a.m. (local time) on January 29, 2026, at the Utilities Building located at, 4325 Liverpool Road, Lake Station, Indiana to familiarize Bidders with this project and bidding requirement. No bid will be accepted from a bidder who does not attend the conference.**
